*This will be a two Judge, two ring trial. Rings will run concurrently. Final schedule will be set in order to follow current Barn Hunt Association rules, NM COVID PHO and number of entries for each class. This cannot be set until entries have been processed. A complete schedule of run orders will be provided with final confirmations!*

Judges will take a lunch break at their discretion.

## AWARDS

Qualifying ribbons will be awarded to all dogs with qualifying scores. Placement ribbons will be awarded to first through fourth place in each of the three height divisions in A: Novice, Open, Senior and Master Classes. Master B Classes will also receive first through fourth place ribbons in each of the three height divisions. Title rosettes will be awarded for those dogs who earn a title. Crazy 8's will receive Qualifying ribbons.

## EXHIBITOR INFORMATION

It is the responsibility of each competitor to read and understand the current Barn Hunt Association, LLC (BHA) Rules prior to participating in this event. Rules can be found at <http://www.barnhunt.com>.

All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50.00 fee for all returned checks. Exhibitors are responsible for complete, accurate and legible information on entry forms; illegible or incomplete entries do not qualify as valid entries. No entries will be taken over the phone or through email. Move ups are allowed next trial or next day.

**Entry Gates** will open 1 hour before Start Times. Check in will be at the secretary station and will be available up to the General Briefing. Gates will close 30 minutes after the last dog runs.

General Briefing will be held 20 minutes before start time. First dogs in blinds 5 minutes before class schedule time.

Judges are limited to 8 hours of judging and a maximum run value, which will require this club to limit entries accordingly. Any judge of record at this Event may be used in any ring. Qualifying scores will show the Judge who designed the course.

Blinds are 10 ft x 15 ft tents with soft sides.

Make check payable Bosque BarnStormers. Send entries & fees to the trial secretary. (Maximum of 10 dog entries per envelope.) By entering this trial, the exhibitor acknowledges they will be given a non-voting membership to Bosque BarnStormers valid for one year.

There is **NO SMOKING** in this facility or on the grounds.

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In that case, no refund of any fees paid will be made.

Dog exercise areas will be marked. Please pick up after your dog and dispose of waste in appropriate containers outside the building. Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement per BHA regulations.

Any dog that fouls the arena in any way (e.g. urinates, defecates, vomits) will be immediately excused. The handler is expected to clean up after the dog, both in the ring and out. A charge of \$8.00 per bale of straw will be charged for fouled bales.

**Collars and Leashes:** Electronic collars and devices are not allowed on trial grounds. Head halters are not allowed on trial grounds. At no time should dogs be tied out or otherwise left attached to something other than a human. Dogs may not be brought to the line in any disallowed collar. Dogs may not be brought to the line on flexi-leads. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Dogs **MUST** run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced. All dogs must be on leash at all times except when in the ring.

**Refunds:** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy or any other cause beyond the control of the organizing committee. No refund will be given after the closing date except for illness of exhibitor or dog or travel restrictions.

**Bitches in season** are eligible for entry but will be required to be kept separate from all other dogs and will be run in panties at the end of their class. Entry fees for bitches that come into season will be refunded until closing date. The refund request must be accompanied by a letter/email from your veterinarian. *If bringing a bitch in season, please inform the trial committee prior to the trial, and you must inform all exhibitors at the judge's briefing.*

**After the trial closes, entry fees will not be refunded.**

**Loud/Disruptive dogs:** Dogs that are loud and disruptive may be asked to locate away from the rings/crating area and/or staged away from the other dogs getting ready to compete.

Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee.

Terrier sparring is not allowed on test grounds.

Any dog that is sick, injured or lame will be excused from the trial grounds. **Food:** We will have a hospitality table with snacks & water available for all. Lunch will be on your own. Bring food or there are fast food restaurants, grocery stores & other options within a 10-minute drive of the site.

Trial grounds are Handicapped accessible with parking available.

There will be a food truck onsite Friday and Saturday. Sunday - pizza from Dion's will be available for everyone.

A list of nearby food establishments will be sent with the final confirmation.

### Directions for Printing your entry online through the Barnhunt.com site:

A week before our event entries open you can print a form for your dog.

1. Log-in to your account on barnhunt.com
2. Click on Events.
3. Click on Create Mail in Entry.
4. For the Dog you wish to enter click on each button for the correct level. Once you have done this for each day of the **event you must scroll to the bottom of the page.**
5. **Scroll to the bottom of the page and** click the "I understand I must Mail the forms to the secretary" then **hit the Print button at the bottom of the page.**
6. You **must** hit the **PRINT** button. The entry form should pop up on your screen and that is what you will send in as your entry. Do not print the screen with all the buttons.

### **DIRECTIONS TO THE SHOW SITE**

10308 2<sup>nd</sup> St NW. Albuquerque, NM 87114

Traveling north on Interstate I-25, take Exit 233 to Alameda Blvd, Take Alameda Blvd west to 2nd Street. Turn right (north) on 2nd St. Proceed approximately 0.8 miles to an unpaved road just past the Bernalillo County Sheriff's Posse sign. Turn right (east) and proceed approximately 0.2 miles to the arena.

From southbound I-25, take Exit 234 (Tramway/Roy Ave), and turn right (west) onto Roy Ave/556W. Go 1.4 miles to the roundabout and take the 2<sup>nd</sup> exit onto NM 556W for 0.5 miles. Then go left (south) on 2<sup>nd</sup> St. Drive approximately 0.6 miles to the entrance to the Bernalillo County Sheriff's Posse on the left. (Note: The Sandia Mountains are east of Albuquerque.)

There will be signs.
